

REQUIREMENTS TO APPLY FOR ABC ACADEMIC AND LEADERSHIP SCHOLARSHIPS

- To apply for any financial aid, you must complete the Free Application for Federal Student Aid (FAFSA).
- Must be a full-time student (12 or more credit hours)
- To apply for **ALL** Arlington Baptist College scholarships, you must complete the scholarship application along with your final high school GPA and scores from either the SAT or ACT.
- All academic scholarships and grants are for tuition only. Scholarships are to cover no more than the difference between your academic tuition costs and your FAFSA award. Scholarship credits cannot exceed the balance owed. Excess funding may not be carried over or exceed tuition costs for each semester.
- Transfer students with less than 30 hours of college credit will be assessed for academic scholarships by their ACT/SAT score and college GPA. If you have accumulated at least 30+ hours of college credit, the college GPA will be the basis for the academic scholarship. If you have attended more than one college, then an average of all transcripts will be used to calculate cumulative GPA.
- **Deadlines for new fall applicants is July 31 for the fall semester, and December 31 for the new spring applicants.**
- **Returning students can only apply for the Leadership Scholarships in the fall semester. Deadline is July 31.**

PRESIDENT'S SCHOLARSHIP FOR NEW FRESHMAN AND TRANSFERS (UP TO \$6000)

This scholarship is a tuition only scholarship offered to beginning freshman students and incoming transfer students. The President's Scholarship is based on academic achievement and is awarded to students with a minimum high school GPA of 3.75 on a 4.0 scale and a combined SAT score of 1200 or above on the Critical Reading and Mathematics portions of the test OR a composite ACT score of 27. Transfer students will be awarded the President's Scholarship if their cumulative (from all colleges) transfer GPA is a minimum 3.75 on a 4.0 scale. The transfer student must have been registered for at least one semester at the full-time status (12 semester hours) with no course withdrawals. The ACT or SAT score will be required if the student transfers in less than 30 credit hours. If more than 30 hours are transferred, the ACT/SAT requirements will be waived. A first time student with dual credit hours will meet the scholarship requirements for a beginning freshman and not the requirements for a transfer student. Students receiving the President's Scholarship may continue receiving a reduced scholarship of \$5000 per year for years 2-4 providing they meet the following requirements:

1. Maintain a grade of "B" or above in Christian Service
2. Maintain a cumulative GPA of 3.75 or above. If the student's cumulative GPA should fall between 3.74 and 3.5, the scholarship will be reduced to the Dean's Scholarship amount until the cumulative GPA is raised to 3.75 or higher. At that point, the President's Scholarship will be reinstated.

3. Be a full-time student (12 or more credit hours)
4. Any student placed on disciplinary probation is subject to forfeiting scholarship funds.
5. All general requirements for initial qualifications must be upheld.

DEAN'S SCHOLARSHIP FOR NEW FRESHMAN AND TRANSFERS (UP TO \$4000)

This scholarship is a tuition only scholarship offered to beginning freshman students and incoming transfer students. The Dean's Scholarship is based on academic achievement and is awarded to students with a minimum high school GPA of 3.5 on a 4.0 scale and a combined SAT score of 1100 or above on the Critical Reading and Mathematics portions of the test OR a composite ACT score of 24. Transfer students will be awarded the Dean's Scholarship if their cumulative (from all colleges) transfer GPA is a minimum 3.50 on a 4.0 scale. The transfer student must have been registered for at least one semester at the full-time status (12 semester hours) with no course withdrawals. The ACT or SAT score will be required if the student transfers in less than 30 credit hours. If more than 30 hours are transferred, the ACT/SAT requirements will be waived. A first time student with dual credit hours will meet the scholarship requirements for a beginning freshman and not the requirements for a transfer student. Students receiving the Dean's Scholarship may continue receiving a reduced scholarship of \$3000 per year for years 2-4 providing they meet the following requirements:

1. Maintain a grade of "B" or above in Christian Service
2. Maintain a cumulative GPA of 3.5 or above. If the student's cumulative GPA should fall between 3.49 and 3.25, the scholarship will be reduced to the Victory Scholarship amount until the cumulative GPA is raised to 3.50 or higher. At that point, the Dean's Scholarship will be reinstated.
3. Be a full-time student (12 or more credit hours)
4. Any student placed on disciplinary probation is subject to forfeiting scholarship funds.
5. All general requirements for initial qualifications must be upheld.

VICTORY SCHOLARSHIP FOR NEW FRESHMAN AND TRANSFERS (UP TO \$2000)

This scholarship is a tuition only scholarship offered to beginning freshman students and incoming transfer students. The Victory Scholarship is based on academic achievement and is awarded to students with a minimum high school GPA of 3.25 on a 4.0 scale and a combined SAT score of 1100 or above on the Critical Reading and Mathematics portions of the test OR a composite ACT score of 22. Transfer students will be awarded the Victory Scholarship if their cumulative transfer GPA is a minimum

3.25 on a 4.0 scale. The transfer student must have been registered for at least one semester at the full-time status (12 semester hours) with no course withdrawals. The ACT or SAT score will be required if the student transfers in less than 30 credit hours. If more than 30 hours are transferred, the ACT/SAT requirements will be waived. A first time student with dual credit hours will meet the scholarship requirements for a beginning freshman and not the requirements for a transfer student. Students receiving the Victory Scholarship may continue receiving a reduced scholarship of \$1000 per year for years 2-4 providing they meet the following requirements:

1. Maintain a grade of "B" or above in Christian Service
2. Maintain a cumulative GPA of 3.25 or above. If the student's cumulative GPA should fall between 3.24 and 3.0, the scholarship will be reduced to the Patriot Scholarship amount until the cumulative GPA is raised to 3.25 or higher. At that point, the Victory Scholarship will be reinstated.
3. Be a full-time student (12 or more credit hours)
4. Any student placed on disciplinary probation is subject to forfeiting scholarship funds.
5. All general requirements for initial qualifications must be upheld.

PATRIOT SCHOLARSHIP FOR NEW FRESHMAN AND TRANSFERS (UP TO \$1000)

This scholarship is a tuition only scholarship offered to beginning freshman students and incoming transfer students. The Patriot Scholarship is based on academic achievement and is awarded to students with a minimum high school GPA of 3.0 on a 4.0 scale and a combined SAT score of 1000 or above on the Critical Reading and Mathematics portions of the test OR a composite ACT score of 21. Transfer students will be awarded the Patriot Scholarship if their cumulative transfer GPA is a minimum 3.0 on a 4.0 scale. The transfer student must have been registered for at least one semester at the full-time status (12 semester hours) with no course withdrawals. The ACT or SAT score will be required if the student transfers in less than 30 credit hours. If more than 30 hours are transferred, the ACT/SAT requirements will be waived. A first time student with dual credit hours will meet the scholarship requirements for a beginning freshman and not the requirements for a transfer student. Students receiving the Patriot Scholarship may continue receiving a reduced scholarship of \$500 per year for years 2-4 providing they meet the following requirements:

1. Maintain a grade of "B" or above in Christian Service
2. Maintain a cumulative GPA of 3.0 or above. If the student's cumulative GPA should fall below a 3.0, the student becomes ineligible for scholarship funds until the cumulative GPA is raised to 3.0 or higher.
3. Be a full-time student (12 or more credit hours)

4. Any student placed on disciplinary probation is subject to forfeiting scholarship funds.
5. All general requirements for initial qualifications must be upheld.

RESIDENT LEADERSHIP SCHOLARSHIP (\$2000) (only 25 scholarships are available)

This scholarship is a tuition only scholarship offered to incoming students and returning students. The Resident Leadership Scholarship is based on academic achievement, Christian Service achievement, and leadership service in their local church. The Resident Leadership Scholarship is awarded to students who exhibit and model leadership behavior in their Christian life and lay, on campus, off campus, in the residence halls, and in their local church. First time students must submit a Leadership Application and a letter of recommendation (on church letterhead) from the pastor of the church they are currently attending as to how the student is involved in a leadership role at his/her church. Students receiving the Resident Leadership Scholarship may continue to receive the Resident Leadership Scholarship each year, providing the student reapplies and meets the following requirements:

1. Maintain a grade of "B" or above in Christian Service
2. Maintain a cumulative GPA of 3.0 or above. If the student's cumulative GPA should fall below a 3.0, the student becomes ineligible for scholarship funds until the next calendar year.
3. Submit a letter of recommendation from two faculty members of Arlington Baptist College. Recommendations will be based on class attendance, participation, character and leadership within the classroom setting. Recommendations must be from a professor of a class you took in the term immediately preceding the fall term for which you are applying.
4. Be a full-time student (12 or more credit hours)
5. Any student placed on disciplinary probation is subject to forfeiting scholarship funds.
6. All general requirements for initial qualifications must be upheld.

NON-RESIDENT LEADERSHIP SCHOLARSHIP (\$1000) (only 25 scholarships are available)

This scholarship is a tuition only scholarship offered to incoming students and returning students. The Non-Resident Leadership Scholarship is based on academic achievement, Christian Service achievement, and leadership service in their local church. The Non-Resident Leadership Scholarship is awarded to students who exhibit and model leadership behavior in their Christian life and lay, on campus, and off campus, and in their local church. First time students must submit a Leadership Application and a letter of recommendation (on church letterhead) from the pastor of the church they are currently attending as to how the student is involved in a leadership role at his/her church. Students receiving the Resident

Leadership Scholarship may continue to receive the Resident Leadership Scholarship each year, providing the student reapplies and meets the following requirements:

1. Maintain a grade of "B" or above in Christian Service
2. Maintain a cumulative GPA of 3.0 or above. If the student's cumulative GPA should fall below a 3.0, the student becomes ineligible for scholarship funds until the next calendar year.
3. Submit a letter of recommendation from two faculty members of Arlington Baptist College. Recommendations will be based on class attendance, participation, character and leadership within the classroom setting. Recommendations must be from a professor of a class you took in the term immediately preceding the fall term for which you are applying.
4. Be a full-time student (12 or more credit hours)
5. Any student placed on disciplinary probation is subject to forfeiting scholarship funds.
6. All general requirements for initial qualifications must be upheld.
